Georgia House of Representatives – The People’s House

This letter is a call to action for those who respect and protect our State and Federal Constitutions. Abstract:

The suspicious results of the 2020 Presidential Election have further divided an already divided nation. No elected official, judge, or member of the various bureaucracies has kept their constitutional oath to keep, 'We the People' free. Massive amounts of data indicating a *Mathematically Impossible* result supported by thousands of sworn affidavits. No subpoenas have been issued nor has any form of serious investigation taken place at any level of our government and indications are that foreign state actors may be involved. The media has also been complicit in this betrayal of transparency. The absence of robust and transparent elections has effectively and literally caused our republic to cease to exist. Seventy-Five million voters will not stand by silently and continue to live lawfully in a lawless society. It is time for those who 'We the People' have charged with preserving the republic perform as their sworn oath requires. All that is being sought is the truth. When half the country believes something is amiss, it is the duty of our government to provide complete transparency.

Introduction:

Many methodologies appear to have been used to interfere in the 2020 election, some of those methodologies have been proven in certain states. The fact that they have been proven in certain states is sufficient indication that those methodologies should be researched in the state of Georgia. An attack on one state is, constitutionally speaking, an attack on all states; Article Four, Section Four reads:

The United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence.

The breakdown of the system of checks and balances was absolute, starting with Executive direction to use Dominion voting machines and extensive use of mail in voting, both in direct violation of Article One, Section Four of the US Constitution; it reads:

The Times, Places and Manner of holding Elections for Senators and Representatives, shall be prescribed in each State by the Legislature thereof; but the Congress may at any time by Law make or alter such Regulations, except as to the Places of choosing Senators.

For the sake of simplicity and clarity we will break down the allegations into two categories; manual and systemic.

Manual voter fraud is defined as any means other than electronic manipulation of votes. Manual voter fraud has or appears to have taken place in numerous ways across the country as well as specifically in our state of Georgia.

Those manual voter fraud methods used specifically in Georgia include:

“From the figure, we see that the largest category of potentially illegal votes is that of absentee ballots cast requested before or after the statutory deadline. In the state of Georgia, voters have 180 days prior to Election Day to request absentee ballots, according to state law.⁴ However, during the 2020 Presidential Election, Georgia officials counted over 305,700 ballots cast by individuals who had requested absentee ballots more than 180 days before the absentee ballot request deadline, in blatant violation of Georgia Election Code.⁵ From the figure, we also see that 10,000 ballots of deceased individuals were counted.⁶ 15,700 votes were counted from “ghost” voters, that is, voters who requested and submitted ballots under the names of voters who no longer reside at a particular address.⁷ Similarly perplexing is that over 1,000 voters without an address cast ballots.⁸ Voting machines –which Georgia election officials were in an inexplicable rush to install leading up to the 2020 election⁹ likewise may account for a substantial number potentially illegal ballots.¹⁰ There were also over 40,000 cases of voters voting in counties in which they did not legally reside, as well as over 66,000¹¹ voters who had successfully cast ballots even though they were under the legal voting age of 18.”

In Georgia and other states Covid-19 was used as an unconstitutional (as these were executive mandates and not dully passed laws) to massively increase the use of mail in and absentee voting. Additionally, there are substantiated claims of around malfeasance at voting and tabulation centers.

Allegations of this sort include:

1. Absentee votes returned in exceeding short time frames from their mail-out post mark, including returned prior to mail-out date:
2. Absentee and mail in votes without creases
3. Terminating counting prior to totals being known
4. Resuming counting of votes absent any republicans being present
5. Blocking republicans from performing their audit function
6. Ballots appearing after hours
7. No down-ballot votes cast
8. Massive requirements for manual vote “adjudication”
9. Cast ballots destroyed
10. The appearance of printed votes being cast
11. Large batches of votes with NONE for President Trump
12. Mathematically impossible spikes in Biden vote counts
13. Executive branch blocking forensic audits

Systemic voter fraud is defined as electronic manipulation of votes at any place in the voting ecosystem. The allegations surrounding systemic irregularities are even more alarming as there appears to have been substantial foreign state actor involvement; an assault on the United States of America.

Indications of systemic voting irregularities include:

1. Fractional vote storage
2. Weighted race capabilities
3. Closed source voting systems
4. Voting systems proven to be connected to the internet
5. Video (Live TV broadcasts) evidence of votes going from President Trump to Biden
6. The use of “Unique Names” to “create voters”

Given the large numbers and varied nature of the alleged fraud it is certainly understandable that large portions of voters are, at very least suspicious of the November 3, and January 5, Georgia Senate runoff, election results. The allegations being made are not of simple sloppiness, but appear to be a criminal, coordinated and concerted effort to take over the United States of America. These cases deserve to be heard by a jury of we the people. Overwhelming probable cause exists, and as such the Georgia legislature must implore the Georgia Bureau of Investigation open a criminal investigation covering all aspects of voter fraud, and to utilize experts in varied fields in a complete effort to uncover the truth and begin to restore faith in our elections and our government generally. Additionally, the Georgia legislature must mandate that no electronic voting system be used in any future election, effective immediately.
