SEPARATION OF CHURCH AND STATE

The First Amendment to the United States Constitution contains what is known as the "Establishment Clause":

"Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof."

The Constitution was amended by the founding fathers to ensure that there would be no state religion, as in England, where the Church of England was "by law, established".

This amendment precluded the state from forcing membership in any particular religion and prohibited government from bridling, controlling or otherwise manipulating the exercise of one's religious faith.

Man is gifted with free will by his Creator to accept God and His truth or, at his peril, reject Him. To insist on or force participation in any religion is a violation of the gift of free will and a violation of man's dignity.

In 1947, the Supreme Court handed down a decision, crafted by Justice Hugo Black, which enshrined the phrase "There shall be a wall of separation between church and state." Ironically, what was at the time of our nation's founders, the commonly accepted understanding of "separation", was penned by Thomas Jefferson in a letter to a Baptist community in Danbury Connecticut in 1802, to underscore the right to practice religion as one chooses, without interference from the state.

However, since the enshrinement of the phrase "separation of church and state" by the Supreme Court in 1947, secular judges have removed religious studies and prayer from public schools, the public display of religious symbols, including the Ten Commandments, and are attempting to remove consideration of God and the natural law from all aspects of the public sector, with potentially disastrous results.

This interpretation of the First Amendment: "separation of church and state", has become, in practice, separation of the state from God. This is a fundamental and serious error since governments derive their sovereignty from God for the sole purpose of protecting and fostering the common good. To banish God, Who is the source of all goodness, is a grievous error, indeed, and an offense against Him and all the people, since without the absolute truth of natural law, the powerful become the rule markers of tyranny.
